

## Game Number 2108 BRINGIN' HOME THE BACON

- 1. The name of scratch-off game number 2108 is "BRINGIN' HOME THE BACON".
- 2. Tickets in scratch-off game number 2108 shall sell for two dollars (\$2) per ticket, unless otherwise adjusted by temporary price reductions or other promotional activities conducted or authorized by the Commission.
- 3. (a) Each ticket in scratch-off game number 2108 shall contain a total of twelve (12) play symbols and ten (10) prize symbols under a scratch-off material covering the game play data area.
- (b) Each play symbol includes a caption that corresponds with and verifies the play symbol as follows:



(c) Each prize symbol includes a caption that corresponds with and verifies the prize symbol as follows:



- (d) If a question arises as to a play or prize symbol, the caption that corresponds with the play or prize symbol will be used for final clarification.
  - 4. The:
  - (1) retailer validation code;
  - (2) game/pack/ticket number; and
  - (3) validation number;

that appears on each ticket in scratch-off game number 2108 are for Commission or retailer use only and cannot be used or played as a play or prize symbol to win a prize.

- 5. (a) To play a ticket in scratch-off game number 2108, the ticket must be validly purchased and the scratch-off material covering the game play data area must be fully removed.
  - (b) If any of the play symbols in the area labeled "WINNING SYMBOLS" match any

of the play symbols in the area labeled "YOUR SYMBOLS", the ticket may be redeemed for a prize in the amount represented by the prize symbol that is located directly below and corresponding with the matching play symbol.

(c) If a "HNJX" (BACON STRIPS) symbol is revealed in the play area labeled "YOUR SYMBOLS", the ticket may be redeemed for a prize three (3) times the amount represented by the prize symbol that is located directly below and corresponding with the "

" (BACON STRIPS) play symbol.

- (b) The number of prizes and the estimated odds provided in subsection (a) are calculated based on print quantity. The actual number of prizes and the chances of winning a prize will vary depending on the actual quantity of tickets printed and as prizes are claimed.
- (c) If the print quantity is changed during production of this game or due to subsequent reorders of the game, the ratio of prizes and total value of all prizes to the print quantity will be proportionately maintained so that the overall odds and prize payout percentage will approximate the values provided in subsection (a).
- (d) Prizes of 20 years of bacon will be paid out in twenty (20) annual installments of bacon valued (at the time of each annual installment) at two hundred fifty dollars (\$250) or as a lump sum payment of five thousand dollars (\$5,000).
- (e) Eighteen thousand nine hundred seventeen dollars and fifty-seven cents (\$18,917.57) in prizes is to be awarded through the Hoosier Lottery Bringin Home the

Bacon Giveaway 2<sup>nd</sup> Chance Promotion. The value of the 2<sup>nd</sup> chance prizes are included in the total value of all prizes, but are not reflected in odds calculations.

- 7. The Hoosier Lottery Bringin Home the Bacon Giveaway 2<sup>nd</sup> Chance Promotion Rules adopted by the Hoosier Lottery on May 11, 2015, are hereby incorporated by reference and shall govern the conduct of the Hoosier Lottery Bringin Home the Bacon Giveaway 2<sup>nd</sup> Chance Promotion.
