A BILL ENTITLED

1 AN ACT concerning

2 **Agriculture – Neonicotinoid Pesticide – Labeling Requirement**
3 **(Pollinator Protection Act of 2015)**

4 FOR the purpose of prohibiting a person from selling in the State certain seeds, material,
5 or plants that have been treated with a neonicotinoid pesticide unless the seeds,
6 material, or plants bear a label with a certain statement; prohibiting a person from
7 selling in the State, on or after a certain date, a neonicotinoid pesticide unless the
8 person also sells a restricted-use pesticide; prohibiting a person from using a
9 neonicotinoid pesticide on or after a certain date unless the person is a certified
10 applicator, a farmer who uses the product for a certain purpose, or a veterinarian;
11 defining certain terms; and generally relating to a neonicotinoid pesticide.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That the Laws of Maryland read as follows:

25 **Article – Agriculture**

2 (a) In this subtitle the following words have the meanings indicated.

3 (c) "Certified applicator" means a person who is certified by the Secretary under
4 this subtitle.

5 (r) "Restricted use pesticide" means a pesticide so classified by the provisions in
6 this title or by the federal government or the Secretary of Agriculture, State of Maryland.

7 **SUBTITLE 2A. PLANTS TREATED WITH PESTICIDES.**

8 **5-2A-01.**

9 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**
10 **INDICATED.**

11 **(B) "NEONICOTINOID PESTICIDE" MEANS ANY PESTICIDE CONTAINING A**
12 **CHEMICAL BELONGING TO THE NEONICOTINOID CLASS OF CHEMICALS, INCLUDING:**

13 **(1) IMIDACLOPRID;**

14 **(2) NITHIAZINE;**

15 **(3) ACETAMIPRID;**

16 **(4) CLOTHIANIDIN;**

17 **(5) DINOTEFURAN;**

18 **(6) THIAACLOPRID;**

19 **(7) THIAMETHOXAM; OR**

20 **(8) ANY OTHER CHEMICAL DESIGNATED BY THE DEPARTMENT AS**
21 **BELONGING TO THE NEONICOTINOID CLASS OF CHEMICALS.**

22 **(C) "NURSERY STOCK" MEANS:**

23 **(1) ANY HARDY PLANT OR PLANT THAT SURVIVES MARYLAND**
24 **WINTERS, INCLUDING A DECIDUOUS OR EVERGREEN TREE, SHRUB, OR WOODY VINE,**
25 **WHETHER CULTIVATED, NATIVE, OR WILD, AND ALL VIABLE PARTS OF THE PLANT;**

1 **(2) ANY NONHARDY PLANT OR PLANT PART TO BE DISTRIBUTED IN**
2 **ANOTHER STATE THAT REQUIRES PLANT INSPECTION AND CERTIFICATION BEFORE**
3 **ENTERING THAT STATE; AND**

4 **(3) ANY OTHER PLANT INCLUDED BY THE SECRETARY, IF**
5 **REGULATING ITS MOVEMENT IS NECESSARY TO CONTROL ANY DANGEROUSLY**
6 **INJURIOUS PLANT PEST.**

7 **5-2A-02.**

8 **(A) A PERSON MAY NOT SELL IN THE STATE ANY SEED, PLANT MATERIAL,**
9 **NURSERY STOCK, ANNUAL PLANT, BEDDING PLANT, OR OTHER PLANT THAT HAS**
10 **BEEN TREATED WITH A NEONICOTINOID PESTICIDE UNLESS THE SEED, PLANT**
11 **MATERIAL, NURSERY STOCK, ANNUAL PLANT, BEDDING PLANT, OR OTHER PLANT**
12 **BEARS A LABEL WITH THE FOLLOWING STATEMENT:**

13 **“WARNING: BEES ARE ESSENTIAL TO MANY AGRICULTURAL CROPS. THIS**
14 **PRODUCT HAS BEEN TREATED WITH NEONICOTINOID PESTICIDES, FOUND TO BE A**
15 **MAJOR CONTRIBUTOR TO BEE DEATHS AND THE DEPLETION OF THE BEE**
16 **POPULATION.”**

17 **(B) ON OR AFTER JANUARY 1, 2016, A PERSON MAY NOT SELL IN THE STATE**
18 **A NEONICOTINOID PESTICIDE UNLESS THE PERSON ALSO SELLS A RESTRICTED-USE**
19 **PESTICIDE, AS DEFINED IN § 5-201 OF THIS TITLE.**

20 **(C) ON OR AFTER JANUARY 1, 2016, A PERSON MAY NOT USE A**
21 **NEONICOTINOID PESTICIDE UNLESS THE PERSON IS:**

22 **(1) A CERTIFIED APPLICATOR, AS DEFINED IN § 5-201 OF THIS TITLE;**

23 **(2) A FARMER WHO USES THE PESTICIDE FOR AGRICULTURAL**
24 **PURPOSES, INCLUDING CROP PRODUCTION, LIVESTOCK, POULTRY, AND NONCROP**
25 **AGRICULTURAL FIELDS; OR**

26 **(3) A VETERINARIAN.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
28 October 1, 2015.
